

DMCA Policy

Effective May 27, 2026.

1. Notice of Copyright Infringement

Seyffert Art LLC, doing business as Seyff respects the intellectual property of others and asks that visitors to and users of our website (seyff.co) and other Seyff platforms do the same. In accordance with the Digital Millennium Copyright Act of 1998 (“DMCA”), 17 U.S.C. § 512, Seyff has adopted the policy set forth below (this “Policy”).

2. Notification of Claimed Infringement

If you believe in good faith that any content on the Site infringes your copyright, please submit a written notification to our Designated Agent. To be effective under the DMCA, your notification must include all of the following:

- A physical or electronic signature of the person authorized to act on behalf of the owner of the copyright that is allegedly infringed.
- Identification of the copyrighted work claimed to have been infringed, or, if multiple works at a single online site are covered by a single notification, a representative list of such works.
- Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, with information reasonably sufficient to permit us to locate the material.
- Your name, address, telephone number, and email address.
- A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

3. Designated Agent for Notice of Claims of Copyright Infringement

4. Counter Notification

If you believe that content of yours that was removed (or to which access was disabled) is not infringing, or that you have authorization from the copyright owner, the copyright owner’s agent, or the law to post and use the content, you may submit a counter notification containing the following information to our Designated Agent:

- Your physical or electronic signature.
- Identification of the content that has been removed or to which access has been disabled and the location at which the content appeared before it was removed or disabled.
- A statement under penalty of perjury that you have a good faith belief that the content was removed or disabled as a result of mistake or a misidentification of the content.
- Your name, address, telephone number, and email address, a statement that you consent to the jurisdiction of the federal court located within the Eastern District of New York, and a statement that you will accept service of process from the person who provided the original notification of the alleged infringement.

If a counter notification is received by our Designated Agent, Seyff may send a copy of the counter notification to the original complaining party informing that person that Seyff may replace the removed content or cease disabling it in 10 business days. Unless the copyright owner files an action seeking a court order against the content provider, the removed content may be replaced, or access to it restored, in 10 to 14 business days or more after receipt of the counter notification.

5. Repeat Infringers

It is Seyff's policy, in appropriate circumstances and at our discretion, to disable and terminate the accounts of users or repeat infringers.

6. False Claims

Please note that under 17 U.S.C. § 512(f), any person who knowingly materially misrepresents that material or activity is infringing, or that material or activity was removed or disabled by mistake or misidentification, may be subject to liability.
